Grades 1, 3, 4, 5, 6, & 7 is \$175.00 for the first child. Each additional child is \$75.00.

Grade 2 is \$250.00 for the first child.

Each additional child in Grade 2 is \$100.00 per child.

If you have an additional child in Grades 1, 3, 4, 5, 6, & 7 the fee is \$75.00 per child.

If you have an additional child in Grade 8 it is \$100.00 per child.

2) I will notify in writing as part of this application that my (under-age) child(ren) will be permitted to walk home, wait for authorized adult to pick up your child(ren) from the curbside, and/or picked up by someone other than yourself - the parent/guardian.

Please make contact with your child’s teacher when picking up so he/she can see you.

4) I understand that as my child(ren) First Teacher I will lead my child(ren) by striving to be a living example of the Catholic faith by attending Holy Mass every Sunday and Holy Days with my child(ren) including the Sacrament of Reconciliation, devotionals, etc.

- 5) I understand that my child(ren) is required to attend Sunday Holy Mass (and Holy Days of Obligation) each week at a Roman Catholic Church and have his/her Mass Attendance Form signed (in Grades 1 - 8). The Mass Attendance Form is to be submitted at the end of each month by dropping off at the Rectory Office or emailing to the office.
- 6) I understand that my child(ren) is required to attend Monthly Spiritual Enrichment Seminars at Good Shepherd Academy. Dates/times to be announced in the Annual Calendar.
- 7) I understand and agree that my child(ren) will be taught the full teachings of the Catholic Church, "...even if we are living a way of life that is contrary to those teachings."
- 8) I understand and agree that my child(ren) will be taught: family and sexuality education in a Catholic context, which seeks to foster family values, promote the right to life and the dignity of each human person, to stress the importance of wholesome relationships, and personal responsibility, to teach the value of conscience formation, and to give inspiration for living lives that are moral and chaste. Applicable in Grades 5 - 8.
- 9) *I understand that my child(ren) is required to complete all lessons in order to be promoted to the next grade level and before receiving a sacrament. Students are required to complete each lesson 100%. We encourage parents/guardian to monitor their child's lesson but please do not do their lesson(s) for them.*
